



Manicure Program Syllabus

Description:

The manicure program meets the minimum requirement by the State of Texas. The Texas Department of Licensing and Regulation has approved IHeart Lash Academy and its curriculum. The Scheduled completion time for this 600 Hours clock hour course is 4 months for FULL TIME and 8 months for PART TIME. Students will attend two phases for this program. Phase I is the initial basic training, and Phase II is building confidence, speed and self sufficiency.

Objective:

Upon completion of the manicure course requirements, the graduate will be able to

1. Display personal integrity with self confidence and a positive attitude.
2. Display effective communication skills, visual poise and proper grooming.
3. Display effective employer - employee skills
4. Perform all Manicuring skills at or above a basic level
5. Apply learned theory, technical information and related matter to assure sound judgements, decisions and procedures

To continue to grow as a manicurist, the graduate should to continue to learn new and current information related to skills, trends, and methods for career enhancement in cosmetology and related fields.

Instruction Methods :

Pivot Point Salon Fundamentals curriculum is used in the program. Specific tasks necessary for state board preparation and entry level job skills are taught in sequential steps. Clinic equipment, implements and products are comparable to those used in the industry. Each student received instruction related to performing useful, creative and productive career oriented activities. Education methods used include lecture, demonstration. Textbook study, hands on practice, audio visuals , guest speakers, field trips not exceed 30 hours, projects and activities.

Phase I :

The first four weeks of class are designed to introduce each new enrolling student to both the basic skills and State board practical exam requirements. Each day a set of practical skills will be demonstrated; students are expected to practice over and over in their non demonstration in this time during the first four weeks. During this time students will also attend theory and complete workbook, assignments and a test for each chapter covered in Phase I. An exam guideline will be provided for preparation of the mock state board practical exam. Completion of Phase I is indicated by passing of a Mock State Board Exam.

Phase II :

The next eleven weeks will focus mainly on performing services on clients. The practice will allow the student to refine their skills learned in phase I and to increase speed. During this time students will also attend their complete workbook, assignments, and a test for each chapter covered in Phase II. All missing and late work will be turned in before the student will be allowed to take the final exams. Tracking of all model applications will be done on a provided monthly calendar. Completion of Phase II is indicated by passing a second mock state board written and practical exam with a 70% or better and clocking 600 hours.

Grading :

Students must maintain a minimum grade of average of 75% to be making satisfactory academic progress. Students are graded on theory, practical and clinic work. All grades will be on a 100 point scale. Written tests are generally given on Friday after each textbook chapter. In addition to the test, the workbook and assignment are due on the Friday after each textbook chapter. IF the student does not pass a chapter test , the score will be recored; but the student has one opportunity to re-test. If the re- test score is higher , it will replace the first score. A 10 point penalty applies on each assignment for each day work is late. Two comprehensive written exams are given at the completion of all chapter tests; the minimum passing score on a written final is 80%.
